Reason for Request			
<p>The traditional practice of ESBN has been not to de-energise essential plant where Health & Safety issues may arise.</p> <p>Essential Plant includes but not limited to:</p> <ul style="list-style-type: none"> • Water Pumping/Treatment Systems, Fire Fighting Equipment incl. Alarms, Pumps, etc. • Fire Fighting Equipment incl. Alarms, Pumps, Access gates for Fire Brigade etc. • Sewage systems • Lighting/lifts in indoor/outdoor common areas of apartment blocks/private developments • The electricity used is not for personal use and the tariff applicable is a business tariff. <p>This DR seeks to introduce a new flag to allow for an MPRN to be identified in the Central Market System as Essential Plant. DSO will maintain this flag. This flag is valid for relevant Unmetered DG3/DG4 at a Tmprn level and Business DG5 and higher. The content of the flag will be made available to Suppliers and TSO on the Extranet and the downloadable meter point details file as well as certain messages that are indicated in detail in the following section.</p>

<p>A new flag is proposed to be added to the Harmonised Data Definitions with the name Essential Plant Flag and schema name EssentialPlantFlag.</p> <p>The Harmonised Data Definition for Essential Plant Flag is "As and where an MPRN is determined to be Essential Plant, or where Essential Plant flag has been removed, then this flag will be highlighted."</p> <p>This flag will be a new Boolean Flag. Where the flag appears with a value of 1 it will mean that there is essential plant at this MPRN, and in the exceptional case where this flag appears with a value of 0 this would mean that there is not essential plant at this MPRN.</p>

The EssentialPlantFlag will be at MPRN level within the messages.</p>

<p>With regard to Unmetered Change of Supplier Confirmation, for Grouped Unmetered the 700MM is the relevant message whereas for Single Point Unmetered it is the 105MM, as is the current market design.</p> <p>Where ESB Networks determine that there is a change at an MPRN which affects the value of this flag, then this will be notified on the 301MM. A value of 0 will be sent where a site is no longer essential plant. The flag will be removed from the MPRN. Where a site is becoming essential plant, a value of 1 will be sent and applied to the MPRN. The exception is for Grouped Unmetered MPRNs where the 700 MM Unmetered Characteristics is in play and not the 301MM.</p> <p>Extranet, Downloadable Meter Point Details File</p> <p>The content of the flag will be made available to Suppliers on the Extranet and the Downloadable Meter Point Details file. On the Downloadable Meter Point Details files this field will be made available in the Commercial and Unmetered extracts and directly after the MIC field.</p> <p>Where this flag appears with a value of 1 on the Extranet or the Downloadable Meter Point Details file it will mean that there is essential plant at this MPRN. It is not proposed to populate a value of 0 on the Extranet for MPRNs that are not flagged as Essential Plant</p> <p>Comment: the exact location of the new field on the Extranet will be communicated throughout the implementation phase.</p>
