Change of Supplier Read Arrangement

CR – Customer Read. This indicates that the Supplier will provide a customer read to affect the changeover. The customer read may be provided as part of message 010 (see Meter Readings) or at a later date using message 210. If Customer Reading is used for a Maximum Demand Meter Point then the registration will be rejected.

SC – Scheduled Read. This indicates that the Supplier will await the next scheduled reading date to affect the Change of Supplier using the scheduled reading.

SP – Special Read. This indicates that the Supplier requires the DSO to collect a special read to be used to affect the Change of Supplier.

MC – Meter Change. This indicates that the Supplier requires the DSO to perform a meter configuration change, the opening reads from which will be used to affect the Change of Supplier. If this is used then a Meter Configuration Code must be provided as below.

DR - SoLR Read Arrangement. This is used when an alternate supplier is applying to take on a customer who was with a supplier who has defaulted and is no longer going to be active in the market. The code can be used in QH CoS and will not cause the CoS to reject. If the code is not used during this scenario, the 010 will not be rejected.

MCC

MCC01 - Requestable at COS IF changing from MCC02 or MCC03

MCC02 - Requestable at COS IF changing from MCC01 only

Change of Supplier Estimate Acceptable (Flag)

Please Note: MRSO will disregard an Estimate Acceptable value of 'true' in the following circumstances:

- 1) A New Connection
- 2) A Change of Supplier for a QH Meter Point or an NQH Maximum Demand Meter Point
- 3) Where there has been no actual or customer read in the previous twelve months

Economic Activity Indicator

Please Note: A valid value for Economic Activity Indicator is required if the site is >30kva

Required Date

If the Change of Supplier Read Arrangement is specified as 'CR' (Customer Read) the Required Date must be:

Not earlier than three days before the date of receipt by MRSO of the registration request

Not later than forty days after the date of receipt by MRSO of the registration request

If the Change of Supplier Read Arrangement is specified as 'SC' (Scheduled Read) then the Required Date is not needed and is not validated.

In all other Change of Supplier scenarios the Required Date must be:

Not earlier than five days after the date of receipt by MRSO of the registration request

Not later than forty days after the date of receipt by MRSO of the registration request

Please Note: For a New Connection the Required Date is not validated.

Meter Point Address

The Supplier should use the address as published by DSO as this will aid validation. At a minimum ESB Networks require that sufficient information be provided to allow a site to be uniquely identified – 1 Main St, Gorey, Co. Wexford can be more readily validated than simply 1 Main St. In addition, the address matching software will be unable to validate data if it is provided in an incorrect order, e.g. Co. Wexford, 1 Main St, Gorey. If there is a change of address then, following confirmation of the registration, the Supplier should use message 013 to advise the change.

Optional/Mandatory: Although the following Data Items are optional, note the following caveats:-

Generation Unit Aggregation Code: Mandatory in case of a generator site

COS Read Arrangement: Mandatory if non-profile metering class and not eligible

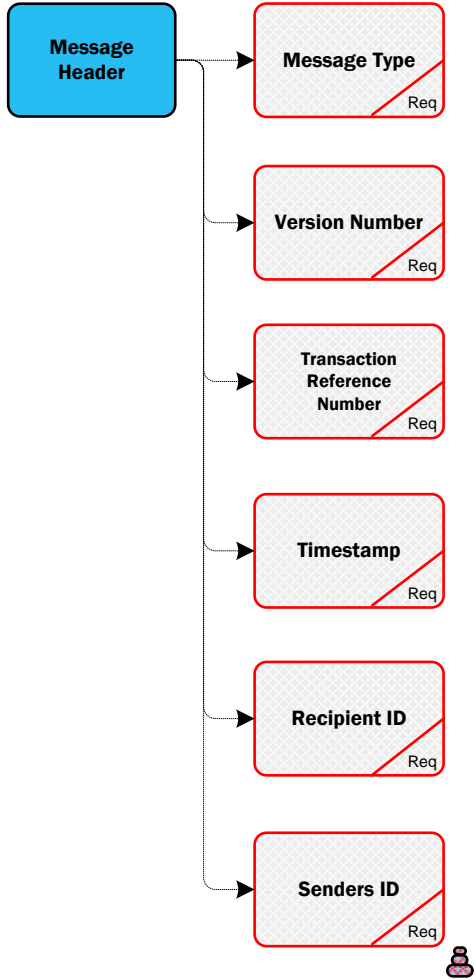
COS Estimate Acceptable: Mandatory if non-profile metering class and not MD not eligible

Required Date: Mandatory for special reads, profile and unmetered meter points
